TRAINING:

Your secretary was recently asked to present the Institute's views to a trainers seminar hosted by TAFE in Perth Western Australia. In the presentation Stephen referenced dollar driven training the result of privatisation of training providers whereby courses were now structured to make a profit above training outcomes. We know that the few full time teachers amongst us will say that training outcomes are still the most important aspect of their job and this came out loud and clear from the trainers at this seminar but it is those in charge of the purse strings that set the rules and in their minds every course must make a profit, hence the proliferation of part time presenters paid by the hour presenting short courses designed for profit not outcomes. Newly graduated plumbing tradespersons are forced to take these courses to complete training that should have been provided during their apprenticeship. Training in Australia appears to be more about cost cutting and economics than preparing a workforce for a lifetime of work.

Your Institute is currently taking a more proactive role in many aspects of the Plumbing Industry including Training. The Institute's views expressed at this seminar included:

- # A need for national consistency in all things plumbing.
- # A need to promote recognition by Governments and the Public of the importance of safe, sound plumbing.
- # Apprentices to be trained in the underlying principles of Plumbing.
- # Retention of the 4 year term of Apprenticeship.
- # Training to be continuous throughout the full 4 year term. (Use it or you will lose it!)
- # Broad spectrum training not specialised streams.
- # End of apprenticeship Capstone Examination(s) set by an independent panel of examiners.
- # Training outcomes not to be dollar driven.

RESIDENTIAL APPRENTICESHIPS:

Well it has finally happened and housing builders in Western Australia have conned the government to allow shortened (2 Years) Apprenticeships in building trades such as bricklaying, plastering, carpentry, we are told that they have their sights on plumbing in 2006. Any push to shorten apprenticeships or reduce training times in residential plumbing is the wrong way round. The fact is that Plumbers in residential construction, renovations and maintenance require as much if not more training than those

in commercial construction due to their work including not only installation and repair of plumbing systems but also design, selection of fittings and materials and compliance with codes, all items provided by specialist engineers and consultants on larger projects.
